



Declaration of Information in support of Indivior's commitment to reporting transparent transfers of value to healthcare professionals, healthcare organisations and patient organisations.

We declare that the information stated below has been prepared in accordance with the requirements of the clauses according to local rules.

This is a true and complete statement reflecting all payments made in the Financial Year 2020 covering the months of January to December 2020.

Patient Organisations

Patient organisations are defined as not-for-profit organisations (including the umbrella organisations to which they belong), mainly composed of patients and/or caregivers, that represent and/or support the needs of patients.

Healthcare Organisations

Any legal organisation that is a healthcare, medical or scientific association or organisation (irrespective of the legal or organisational form) or other teaching institution or learned society (except for patient organisations).

The Company regards all hospitals, Clinical Commissioning Groups (CCGs), GP practices and other places of work for HCP management services related to the treatment of patients, as healthcare organisations. In addition, all medical societies (international, national or local) and all "networks" of associations for HCPs are regarded as healthcare organisations. Private companies such as medical education agencies, or suppliers of "temp" nurses, etc., are not typically regarded as healthcare organisations unless their employees are non-HCPs.
